

Town of New Canaan Community Survey Results

Introduction

The Town of New Canaan conducted a community-wide survey to gather public input related to the development of the Town's 2024 Plan of Conservation & Development. The survey ran for three weeks and gathered 2,306 survey responses (11.2% of the Town's population). These responses provide the Town with significant insight from residents about their values and priorities for the Town's future. This report will summarize the results of the community survey and present key takeaways and full detailed responses.

Survey Monitoring, Analysis & Conclusions

Survey Monitoring & Analysis

Survey responses were collected through both the Survey Monkey virtual platform and in person. All paper copies were inputted into Survey Monkey. The SLR Team monitored survey participation and flagged all IP addresses that were used for more than one survey. These surveys were further reviewed to determine the authenticity and credibility of each response. Responses that were clearly duplications were eliminated from the analysis. Surveys that answered less than four full questions were also eliminated.

All responses were compiled by Survey Monkey; close-ended responses were tabulated by the platform and reported in percentages and open-ended responses were provided in table format. Open-ended responses were further analyzed by the SLR Team to identify trends and themes among the responses; due to the high volume of responses, artificial intelligence was utilized to help identify these patterns.

Survey Conclusions

- Survey participants are largely content with the quality of life in New Canaan, rating the overall quality of life in Town as an 8.5 out of 10. 61 percent of respondents also feel that the quality of life is the same or better than it was in 2014.
- Reliable cell phone service, traffic congestion, road maintenance, and speeding are the top four quality of life concerns for survey participants across the Town. Speeding is the top concern within the Downtown and South neighborhoods, followed by sidewalks (or lack of sidewalks) and road maintenance. Cell phone service is the number one concern for participants from the East and West neighborhoods, followed by speeding and internet service.
- Participants are mostly satisfied with the variety of housing options within the community but are generally less aware of the quantity of age-restricted housing, assisted living facilities, and continuing care retirement communities. Opinions on the amount of small, single-family homes and affordable housing options are mixed; 51.9 percent of participants feel there are the right amount of small, single-family homes while 39.8 percent feel there are not enough. Meanwhile, 36.2 percent of participants feel there is the right amount of affordable housing, but another 32.8 percent feel there is not enough.

Survey Monitoring, Analysis & Conclusions

- Over 50 percent of participants agree that the Downtown is visually attractive and well lit. They also feel that the buildings are appropriately size and there is a good mix of things to do and places to visit. Walking in Downtown is generally well regarded; sidewalks are wide enough and separated from the road, and it is easy enough to cross the street. Only 16.4 percent of participants, however, feel that they are safe from traffic while biking in Downtown. Parking opinions are more mixed; just under 50 percent feel that parking is affordable and only 31.7 percent consider it easy to find available parking spaces.
- Participants are in agreement regarding transportation related topics in Town; roads are considered adequate by the majority of respondents and over 50 percent of respondents agree or strongly agree that the Town needs more sidewalk and bike infrastructure.
- All Town facilities were classified as excellent, except for roads and sidewalks (adequate) and senior services (don't know). Waveny Park and the Library are the most visited Town facilities. Participants largely agree (or strongly agree) that school facilities are well-maintained, safe, and appropriately funded and that recreational facilities on school grounds are accessible to the community. When asked about parks and recreation facilities and programs, places to bike, skate, and skateboard was the only option noted as not having enough within the Town. Many agree that there are sufficient cultural facilities in Town but also agree that the Town should invest in creating and attracting more. Nearly 40 percent of participants also support expanding the Historic District.
- Over 90 percent of participants had an experience in the last ten years related to loss of power, internet, or phone connection due to storms and the majority of participants do not feel that the Town is doing enough to protect against the loss of power, internet, and phone connections from storms. There is significant uncertainty about the availability of various sustainability programs within the Town, but participants do feel there is enough clothing donation drives, e-waste disposal options, and recycling options.
- The top priority for the Town over the next ten years, according to survey participants, is the continued support and improvement of the education system. Maintaining and improving existing roads and preserving undeveloped land for open space were the second and third ranked priorities, respectively. Encouragement of more non-residential development ranked last among the options.

Section Overview

The community survey asked participants to rate and comment on the quality of life in New Canaan. Questions asked for participant's take on the current quality of life and how it has changed over the last ten years and what makes New Canaan special.

Questions

- How would you rate the overall quality of life in New Canaan?
- How has the quality of life in New Canaan changed since 2014?
- What is special about the quality of life in New Canaan?
- What do you think will be the most important conservation and development issues in New Canaan over the next decade?
- Please indicate whether you have any concerns with the following quality of life issues in your neighborhood or anywhere in New Canaan.

Takeaways

The average rating for the quality of life in New Canaan is 8.6, which was consistent across participants from different neighborhoods. Overall, 61.1 percent of participants feel the quality of life has remained the same or gotten better since 2014.

When asked if they have any concerns related to quality of life issues in their neighborhood or in New Canaan, most topics were flagged by participants as not an issue. Nearly 60 percent of participants agree that reliable cell service is an issue in Town and nearly 50 percent agree that road maintenance, traffic congestion, and speeding are issues in New Canaan.

Participants from the Downtown and South neighborhoods noted that speeding, sidewalk maintenance / lack of sidewalks, and road maintenance are the top three issues in their neighborhood. Participants from the East and West neighborhoods noted that speeding, cell phone service, and internet service are the top issues within their area.

Question 1: How would you rate the overall quality of life in New Canaan?

Participants ranked the quality of life in New Canaan on a scale of zero to ten, with zero indicating a poor quality of life and ten indicating a high quality of life. The average rating for the quality of life in New Canaan was **8.5**.

When compared across neighborhoods, participants from the Downtown and West neighborhoods had an average rating of 8.5 and those from the South and East neighborhoods had an average rating of 8.6.

Question 2: How has the quality of life in New Canaan changed since 2014?

Overall, 61.1 percent of participants feel that the quality of life has remained the same or gotten better since 2014. When compared across neighborhoods the following percentages feel that the quality of life has remained the same or gotten better:

Question 3: What is special about the quality of life in New Canaan?

Question 3 was open-ended and gathered 1,972 responses from participants. Artificial intelligence was used to identify preliminary themes from respondents and those themes were then further reviewed by the SLR Team, using keywords, to verify their significance in the responses. The following are five of the major components that contribute to the high quality of life in New Canaan:

Town Facilities & Services (36.7%) Participants are pleased with the overall quality of community facilities and services. Residents appreciate the variety of services provided by the Town and specifically note the quality of the school system, recreational programming, and cultural institutions. Others commend the Town's commitment to offering services and resources for all demographics as well as the Town's responsiveness to community concerns.

Recreation & Open Spaces (23.7%) Participants note that the Town's parks and open spaces are well maintained and that they appreciate the natural beauty of the community. Waveny Park is highlighted as an excellent community space with a family-friendly atmosphere and the Town's natural landscape and green spaces are also highly valued. Some participants also highlight the importance of environmental conservation and further protecting open spaces.

Safety (17.2%) Respondents feel that the Town is a safe place to live and raise a family. They also note that they appreciate the close-knit nature of the town and the strong relationships among neighbors and feel that these connections contribute to the sense of safety in the community.

Downtown (15.1%) Participants value the vibrancy of Downtown and describe it as charming and active. They enjoy the social elements of the Downtown, like the various community and cultural events held here. Participants express support for the local businesses and appreciate the variety in shopping and dining options as well as the cultural offerings, like the historic character and art exhibitions. Participants also note that the Downtown is accessible from various residential neighborhoods and find its' overall environment to be walkable and family-friendly.

Community Involvement (14.0%) Participants appreciate the community's overall level of engagement. Responses indicate that community spirit and volunteerism contribute heavily to the quality of life in Town. They also value community events and see community involvement and civic pride as a significant piece of the Town's identity.

Question 4: What do you think will be the most important conservation and development issues in New Canaan over the next decade?

Question 4 was open-ended and gathered 1,971 responses from participants. Artificial intelligence was used to identify preliminary themes from respondents and those themes were then further reviewed by the SLR Team, using keywords, to verify their significance in the responses. An overarching theme amongst respondents is concern for overdevelopment, which is primarily tied to maintaining the small-town feel of the community and the potential strain on infrastructure.

Affordable Housing (19.8%) Survey participants had mixed opinions on affordable housing in the community; some are in favor of its continued development, noting that the diversity in housing will keep the Town well-rounded, while others are worried the impact of large-scale, high-density housing developments. Generally, however, respondents feel strongly about the need to balance affordable housing with the Town's existing character. Participants want affordable housing strategically located and are mindful of the existing state mandates related to affordable housing. Many participants emphasize that affordable housing should not come at the expense of open space, natural resources, and historic preservation. They also acknowledge that it is a complex issue that will require careful planning, community input, and collaboration among different stakeholders.

Environmental Conservation & Sustainability (18.4%) Survey responses reflect a community that has a strong commitment to preserving the Town's natural resources, reducing its environmental impact, and preparing for climate-related challenges. Participants have concerns related to development encroaching on open spaces and wetlands and many respondents are advocating for responsible and environmentally conscious development. Respondents also express the need for the Town to take steps to prepare for extreme weather events, rising temperatures, and potential flooding, such as strengthening infrastructure and adopting climate-resilient building practices and energy-efficient technologies. Other related topics that participants discuss include increasing sustainable land care practices and further safeguarding of water resources and water quality.

Infrastructure (15.3%) Ensuring the town's infrastructure is well-maintained is a significant focus for survey participants. Many respondents discussed concerns related to existing infrastructure (roads, sewer and water) and its capacity to handle more development. Respondents also note that the infrastructure's ability to withstand extreme weather conditions, including power and utilities, is a concern. There is also significant discussion on improving internet and cell phone service reliability within the Town (an additional 5.1%).

The housing potion of the community survey addressed the topic of housing diversity within the community.

Takeaways

Most survey participants indicated that New Canaan has about the right amount of various housing types. When respondents who answered "don't know / not sure" are removed, age-restricted housing is the only housing type where the majority of participants feel there are too few of.

Responses also indicate that community members have a lack of awareness about the quantity of four housing types in the community:

- Duplexes
- Age-Restricted Housing
- Assisted Living Facilities
- Continuing Care Retirement Communities

Takeaways

Survey participants feel that there are about the right amount of retail stores, offices, research and development and light industrial / manufacturing facilities, medical and entertainment / cultural facilities, and restaurants in the community. Responses also indicate that community members have less awareness about the quantity of research and development facilities and light industrial and manufacturing facilities.

Participants generally agreed with the statements made about Downtown New Canaan. In particular, over 90 percent of participants agreed or strongly agreed that the Downtown is well lit, buildings are the right size, and that they feel safe from crime there. There are mixed opinions related to how easy it is to find parking and how safe bicyclists feel in the Downtown.

Transportation questions asked participants how they felt about the Town's transportation system and infrastructure.

Takeaways

Participants generally agreed with all statements made regarding New Canaan's transportation system.

Over 50 percent of respondents agree or strongly agree that road conditions are adequate and that the Town needs more sidewalks and bike infrastructure.

Survey participants have mixed opinions regarding the issues of traffic congestion on major roads, the safety of students while biking and walking to school, and the amount of transit options within the Town.

Takeaways

Survey participants find that most Town facilities are excellent quality; local roads and sidewalks are noted as adequate quality and most participants were unaware of the quality of senior services.

Participants largely feel that the school facilities and grounds are well-maintained, recreational facilities at the school are accessible to the community, and that they feel safe on school grounds. Opinions about the amount of daycare and preschool options in Town are mixed, with 45.5 percent of participants holding neutral opinions on it.

Respondents feel there is generally the right amount of the various recreational facilities and programs in Town, with the exception of places to bike, skate, and skateboard.

The majority of respondents (over 50 percent) said that the barriers listed were not applicable to them, as related to their use of community facilities; however, nearly 40 percent of participants listed lack of awareness about programming as a top 3 barrier to using community facilities.

Question 15 was open-ended and gathered 859 responses from participants. Artificial intelligence was used to identify preliminary themes from respondents and those themes were then further reviewed by the SLR Team, using keywords, to verify their significance in the responses.

Park Access, Maintenance, & Amenities (18.7%) Participants hold Waveny Park in high regards and many showed interest in improving the maintenance and accessibility of parks like Kiwanis Park (and beach), Mead Park, Irwin Park, and Ed Dixon Park. There is desire for more playgrounds, skate parks, and basketball and pickleball courts. Participants also note interest in more walking and biking trails at parks and year-round public restrooms for recreation areas. Some participants also mention that the Land Trust properties seem inaccessible and that they should be better advertised.

Walkability & Bikability (17.0%) Participants made numerous comments about establishing green spaces and sidewalks to safely and actively connect community amenities, like schools, residential areas, parks, and recreational spaces. There is a focus on the walkability of Downtown and South Ave, but neighborhoods near East School, West School, and Talmadge Hill Train Station were mentioned as options to expand walkable areas. There was recognition of the excellent community amenities and facilities throughout the Town, but limited accessibility for walking and biking to them. Many participants expressed concern about pedestrian and bicyclists' safety throughout New Canaan.

Teen Programming (7.3%) Participants commented on the need for more teen-oriented recreational options. Specific suggestions included a teen center, ice / roller rink, a skate park, arts and cultural programming, and programming not tied to the schools and not athletic in nature.

Beach Access (4.9%) Various participants showed interest in obtaining beach access. Comments addressed the upkeep and revitalization of Kiwanis Park, as well as discussion about arrangements with neighboring coastal towns to provide beach passes to New Canaan residents.

Accessibility (2.3%) Participants emphasize the need for improved accessibility for various groups, including seniors, individuals with disabilities, and parents with young children. This includes accessible book drops at the library, better transportation options, and social and recreational programs tailored to these groups.

Takeaways

Of the focus areas presented to survey respondents, the highest ranked priority for the Town over the next decade was the continued support and improvement to the education system.

Common concerns for the community over the next decade include infrastructure maintenance and improvements, the quality of the educational system, improvements to downtown, and affordable housing. There is also significant interest in pedestrian and bike infrastructure and more reliable telecommunication services.

Question 21: Please rank the following in terms of priority focus areas for New Canaan over the next ten years. Rank you top priority first and your lowest priority last.

Below are the 11 focus areas presented to survey participants. Continued support and improvement to the education system ranked as the number one priority for participants, with nearly 70 percent ranking the option in their Top 3. Maintaining and improving existing roads ranked second and preservation of undeveloped land for open space ranked third.

Question 22: Do you have any other top priorities for New Canaan over the next ten years?

Question 22 was open-ended and gathered 1,010 responses from participants. Artificial intelligence was used to identify preliminary themes from respondents and those themes were then further reviewed by the SLR Team, using keywords, to verify their significance in the responses.

Infrastructure (24.2%) Infrastructure improvements were a common area of concern. Comments touched on the maintenance of transportation infrastructure (roads, parking, sidewalks), improvements to the reliability of utilities (power, cellular, internet), and increasing the sustainability and climate resiliency of infrastructure (drainage, charging stations, renewable energies). Related to transportation infrastructure, some respondents expressed interest in more frequent, reliable, and express train service during peak commuter hours (like 8-9 am departure and 6-7 pm return from the city).

Schools (10.9%) Participants have a strong sense of pride around the school system and are committed to maintaining the quality of education and ensuring safety within the schools. There was significant interest in investing more into the education system, including suggestions for more cultural and art programs. There was some concern regarding the capacity of schools, specifically the elementary schools and participants suggested expanding the elementary schools' options to respond to increased enrollment and redistributing amenities between schools in Town.

Downtown (7.5%) Participants are interested in keeping the area vibrant and integrating dining, retail, and community spaces in Downtown. Comments mentioned reducing storefront vacancies and some emphasized a need to provide additional support to small businesses to draw more shops into New Canaan and support their retention. There were also discussions related to parking and walkability improvements to Downtown. Darien and Westport Downtown areas were referenced as examples for revitalization that focuses on improving quality of life, sidewalk access, and engaging community areas. There were also suggestions for a Downtown Planning Committee or a Long-Term Downtown Vision Plan.

Question 23: Do you have any other comments or concerns you would like to share with us, or was there something that we missed?

There were 715 additional comments from survey participants that address various concerns and provide suggestions for the Town. The following is a list of some of the topics and suggestions from participants.

Roads & Traffic Conditions. Participants emphasize the need for road improvements, including better maintenance and repaving. Concerns are raised about speeding, drivers failing to stop at pedestrian crossings, and safety issues at intersections like Oenoke Ridge and West Road. Participants would like police to better enforce speed limits within Town. Multiple participants also discussed the need for traffic pattern adjustments at Cherry & Main Streets as well as maintaining vegetation along roads.

Sidewalk Infrastructure / Pedestrian Safety. Participants have suggested adding sidewalks to Hoyt Street, Jelliff Mill Road, and Putnam Road, and connecting parks and schools through sidewalks. Residents highlight the need for safer pedestrian crossings, including proper signaling and painted crosswalks. Respondents note concerns for sidewalk maintenance, particularly those that are brick.

Affordable Housing. Participants have strong opinions about the size, location, and aesthetics of affordable housing within the community. There are suggestions for locating affordable housing within the Cross & Vitti Street neighborhood, near public transportation hubs, and possibly the lumberyard or Vine Cottage. There is opposition to building affordable housing on Weed & Elm Streets.

Downtown. Some participants have observed empty storefronts or underutilized commercial spaces in the downtown area and would like to see these spaces filled with vibrant businesses. They suggested attracting a more diverse range of retailers and businesses to the downtown area to provide a wider array of shopping and dining options. They often prefer unique boutiques, family-owned businesses, and diverse culinary options over large chains.

Schools. Several comments express concerns about overcrowding in the public schools, particularly at the elementary level. There is also a desire to see more diversity and an emphasis on diversity, equity, and inclusion in New Canaan schools.

Telecommunications. Participants highlight the need for improvements to telecommunication infrastructure, including faster and more reliable internet access and improved cell phone service throughout New Canaan.

Section Overview

The 'About You' section of the community survey asked respondents to share information about themselves to better understand the population responding to the survey. Questions were related to demographics and personal history within the Town. 491 participants also took the opportunity to share their contact information for further information on the POCD's development.

Takeaways

Most survey participants were between the ages of 45-64 and over 40 percent have lived in New Canaan for 20 or more years.

Over 50 percent of participants described their household as a family with children at home. Participants were also spread evenly across the neighborhoods within Town.

Nearly 80 percent of participants see themselves living in New Canaan in the next ten years. Those who do not see themselves in New Canaan cited the cost of living and wanting to downsize as the main reasons.
